Commingled materials will be collected by your garbage hauler. Please contact your hauler for your recycling pick-up times and schedule.

Leaf and yard waste materials will be collected by the Township road crew. You can get information on specific collection schedules by calling or stopping in the Township office. <u>NOTE</u>: if the materials are not prepared properly, they will be left at the curb.



Township RECYCLABLES

Ordinance # 207 & Resolution # 2002-17



Residential Recycling

1. Glass

Types: clear, brown & green food/drink bottles & jars only Prep: Remove & discard lids. Rinse.

2. Aluminum

Types: beverage cans only Prep: Rinse & flatten can.

3. Plastic

Types: bottles or jars marked #1 or #2 only Prep: Remove & discard caps, rinse and flatten if possible.

4. Newspaper

Types: entire newspaper and/or merchandiser Prep: Stack in paper bag or bundle with string.

5. Leaf Waste

Types: leaves from trees, bushes & other plants Prep: Rake into long, narrow piles 1-foot from the curb or property's edge. CLEAN LEAVES ONLY!!

6. Recyclable Vegetation (Yard Wastes)

Types: tree trimmings/woody material, green/garden residues, **except grass & poisons** Schedules & definitions of types of collected material are available at the Township office.

Prep: All material placed curbside in small, easily manageable, separate, compact piles. Trimmings can't exceed 3 - 4 inches in diameter &/or 8 feet in length. Residents & businesses are limited to one pick-up truck load (8'1 x 6'w x 4'h) per location per week of collection.

Commercial Recycling

 * Pertains to all commercial, industrial & institutional establishments throughout the Township.

Commercial establishments must recycle the same material as residential, which can be found to the left. In addition to those items, the following materials must be recycled:

1. High Grade Office Paper

- Types: computer, copy machine, envelopes and any other paper except glossy paper and newsprint
- Prep: Stack in paper bag, bundle with string or shred and place everything into a large, clear, plastic garbage bag. KEEP DRY!!

2. Cardboard

Types: any type of clean cardboard, except wax-coated Prep: Flatten boxes and bundle with string. KEEP DRY!!



tities in the Township must ...

- 1 ...thoroughly clean all recyclables or hauler will not collect them.
- 2 ...not place any recyclables in plastic bags of any kind, unless specified in the preparation.
- 3 ...place all glass, aluminum and plastic together in the recycling container. Newspapers can be bundled and placed on top of everything in the container.
- 4 ...keep all office paper and cardboard separate

In case you were wondering if your recycling efforts really mean anything...they do!! In fact, the residents and businesses of the Township did such a great job recycling, that we achieved the following feats:



Because of your great recycling efforts during 1999, the Greater

Lebanon Refuse Authority presented the Township with an award for being one of the top 4 recycling municipalities in the County by recycling a total of 29.3% of material!

In 2001, North Cornwall Township voluntarily recycled a total of 36.92%, which exceeded the State's 35% goal for each recycling municipality in Lebanon County.

Recently, not only have we been awarded 3 pieces of equipment and educational materials from two different State recycling grants, but we have also just received an award for recycling 43% of generated material during the year 2003!

BURNING REGULATIONS

Ordinance # 209

Due to a State regulation regarding the new recycling program, the Township's burning policy has been changed. This DEP regulation states that any and all recyclable material can no longer be burned.

However, there is an exception for farmers only. Farmers of 25 acres or more can obtain an open burning permit from the Township office. This would allow them to burn tree limbs, branches, brush and other similar material that has been wholly generated on their farm only. The permit fees are as follows:

10 for one day OR 100 for one year
