Discussion/Action: Dairy Road Sanitary Sewer Pump Station Study Presentation Mr. Shafer and Mr. Hoffer of ACT One Associates, and Mr. Cichy of Herbert, Rowland & Grubic. prepared a presentation regarding the Dairy Road Pump Station based on the Annual Inspection Reports for the past five (5) years. This pump station services approximately 70% of the Township including North Cornwall Township, portions of Cleona, Cornwall Borough and West Cornwall Township. Components of this pump station are estimated to last 20 years (mechanical/electrical), and 40 years (structural). This pump station structure is 45 years old. A presentation followed listing all the deficiencies/problems with the current pump station, the recommended remedies, and six (6) options to rebuild and replace the pump station. This would be a three (3) year process. No action was taken.
