**Executive Session**: Mr. Abram noted there was an Executive Session held March 3, 2020 to discuss legal and personnel matters. No action was taken.

## **Township Engineer Report:**

Discussion/Action - Siegrist Subdivision Plan. It is a 78 acre property located at 100 Village Drive, amd is being divided into two (2) parcels. The Planning Commission approved the plan unanimously. Mr. Wahmann made a motion to approve the subdivision plan. Mr. Sell seconded the motion. All voted in favor.

Discussion/Action - Springwood Partners/NCC Phase 3 Sanitary Sewer Security Reduction. ACT One is recommending a reduction in the Letter of Credit in the amount of \$30,154.00. Mr. Abram made a motion to approve the reduction of the Letter of Credit for Springwood Partners Phase 3 Sanitary Sewer in the amount of \$30,154.00, maintaining a balance of \$4,115.40. Mr. Wahmann seconded the motion. All voted in favor.

**Approval of Minutes:** Mr. Wahmann made a motion to approve the minutes from the March 3, 2020 meeting as written. Mr. Sell seconded the motion. All voted in favor.

## **PUBLIC SAFETY**

## Police:

Chief Leahy gave his report of the department activities for the month of February. The Chief reviewed the new safety procedures put in place to deal with the COVID-19 virus. And stated that they have entered into a Countywide Emergency Mutual Aid Agreement in conjunction with the Pennsylvania State Police.

He also announced that they will be picking up the first of the two new fleet police cars. The second will be picked up on Friday.

#### Fire:

Mr. Abram presented the fire department reports for the month of February. Due the COVID-19 virus, the fire department is closed to all non-members. Mr. Abram reviewed the safety procedures that the fire department put in place to deal with the virus.

Mr. Long stated that the auto insurance policy will be paying for the damages to the DO vehicle.
