ORDINANCE NO. 330

AN ORDINANCE OF NORTH CORNWALL TOWNSHIP, LEBANON COUNTY, PENNSYLVANIA, AMENDING AND RESTATING IN ITS ENTIRETY THE NORTH CORNWALL TOWNSHIP MOTOR VEHICLE AND TRAFFIC ORDINANCE NO. 273, AS AMENDED AND SUPPLEMENTED; ESTABLISHING GENERAL REGULATIONS INCLUDING DEFINITIONS AND INTERPRETATION, MANNER OF ADOPTING PERMANENT TRAFFIC AND PARKING REGULATIONS, TEMPORARY AND EMERGENCY REGULATIONS, EXPERIMENTAL REGULATIONS, AUTHORITY OF POLICE OFFICERS, PENALTIES FOR DESTROYING AND VIOLATIONS; ESTABLISHING TRAFFIC REGULATIONS INCLUDING MOTOR VEHICLES NOT TO BE DRIVEN OR PARKED ON SIDEWALKS, SPEED LIMITS, DO NOT ENTER STREETS, KEEP OFF SHOULDERS, STOP INTERSECTIONS, PROHIBITING CERTAIN CLASSES OF VEHICLES ON CERTAIN HIGHWAYS, ESTABLISHING AT CERTAIN LOCATIONS RIGHT LANE MUST TURN RIGHT, LEFT LANE MUST TURN LEFT, NO RIGHT TURNS, NO LEFT TURNS, ONE WAY STREETS, LIMITATIONS ON PRIVILEGE OF PASSING, YIELD INTERSECTIONS, UNLAWFUL TO OPERATE OR PARK MOTOR VEHICLES OR MOTOR CARRIER VEHICLES ON HIGHWAYS CLOSED FOR CONSTRUCTION OR REPAIR, AUTHORIZING SPECIAL EVENT HIGHWAYS, AND REQUIRING ACCIDENT REPORTS; ESTABLISHING PARKING REGULATIONS INCLUDING AUTHORIZING PARKING WITHOUT LIGHTS, ESTABLISHING VEHICLES TO BE PARKED WITHIN MARKED SPACES, PROHIBITING PARKING AT ALL TIMES IN CERTAIN LOCATIONS, ON ALL BRIDGES, WITHIN THIRTY FEET OF INTERSECTIONS OR FIFTEEN FEET OF ALLEYS, IN SPECIFIC LOCATIONS ON CERTAIN DAYS, HOURS, AND DURING WINTER SNOW STORMS, ESTABLISHING HANDICAPPED PERSONS AND/OR DISABLED VETERANS PARKING ZONES, PROVIDING FOR PARKING OR STORAGE OF MAJOR RECREATIONAL EQUIPMENT, TRUCKS, AND SPECIALTY EQUIPMENT VEHICLES, AND ESTABLISHING PENALTIES FOR VIOLATION; ESTABLISHING SNOW AND ICE EMERGENCY REGULATIONS INCLUDING DECLARATION OF SNOW AND ICE EMERGENCIES, PROHIBITING PARKING ON SPECIFIC HIGHWAYS DURING EMERGENCY, ESTABLISHING RESTRICTIONS ON OPERATION OF MOTOR VEHICLES AND MOTOR CARRIER VEHICLES ON SUCH STREETS, PROVIDING FOR PLACEMENT OF SIGNS ALONG HIGHWAYS AFFECTED AND INFORMATION ON EXISTENCE OF EMERGENCY ON HIGHWAYS AFFECTED, AND PENALTIES FOR VIOLATION; AND PROVIDING FOR THE REMOVAL AND IMPOUNDING OF ILLEGALLY PARKED VEHICLES INCLUDING THE AUTHORITY TO REMOVE AND IMPOUND ILLEGALLY PARKED VEHICLES, PROVIDING FOR APPROVED STORAGE GARAGES, REQUIRING GARAGES TO BE BONDED, ESTABLISHING AND REQUIRING PAYMENT OF TOWING AND STORAGE CHARGES, REQUIRING NOTIFICATION OF REMOVAL AND IMPOUNDING OF VEHICLES, ESTABLISHING EFFECT OF PAYMENT OF TOWING AND IMPOUNDING CHARGES WITHOUT PROTEST, ESTABLISHING EFFECT OF PAYMENT OF TOWING AND IMPOUNDING CHARGES UNDER PROTEST, REQUIRING KEEPING RECORDS OF VEHICLES REMOVED AND IMPOUNDED,

PROVIDING OWNER OR OPERATOR OF VEHICLE REMAINS LIABLE FOR FINE OR PENALTY, AND RESTRICTIONS UPON REMOVAL OF VEHICLES.

BE IT ENACTED AND ORDAINED, by the Board of Supervisors of North Cornwall Township, Lebanon County, Pennsylvania (the "Township"), and it is hereby ENACTED AND ORDAINED by the authority of the same as follows:

Section 1. The North Cornwall Township Motor Vehicle and Traffic Ordinance No. 273, as amended by Ordinances Nos. 292, 298, 306, 323, and 328, is hereby amended and restated in its entirety as follows:

PART 1. GENERAL REGULATIONS.

Section 101. Definitions and Interpretation.

- (A) Words and phrases, when used in this Ordinance, shall have the meanings as described in The Vehicle Code of Pennsylvania, Title 75, Vehicles, Chapter I, General Provisions, Section 102, as now in force, or as hereafter amended, enacted or reenacted, except where the context clearly indicates a different meaning.
- (B) The terms "legal holidays" as used in this Ordinance shall mean and include: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas.
- (C) The term "Township" as used in this Ordinance shall mean North Cornwall Township, Lebanon County, Pennsylvania.
- (D) In this Ordinance, the singular shall include the plural, the plural shall include the singular, and terms of gender shall mean either gender or the neutral.

Section 102. Manner of Adopting Permanent Traffic and Parking Regulations. All traffic and parking regulations of a permanent nature shall be enacted as ordinances or as parts of ordinances or as amendments to ordinances of North Cornwall Township.

Section 103. Temporary and Emergency Regulations. The Board of Supervisors shall have the following powers to regulate traffic and parking temporarily and in time of emergency:

- (A) In the case of fire, flood, storm or other emergency, to establish temporary traffic and/or parking regulations.
- (B) In the case of emergency or to facilitate public works, or in the conduct of parades, processions or public events, to restrict or prohibit traffic and/or parking in limited areas for periods of not more than seventy-two (72) hours.

Such temporary and emergency regulations shall be enforced by the Police Department in the same manner as permanent regulations. Any person who shall operate or park a vehicle or motor carrier vehicle in violation of any such regulations, or who shall move, remove, destroy or deface any sign or marking erected, posted or made to give notice of any such regulation, shall, upon conviction thereof, be liable for the penalty set forth in the applicable law or elsewhere in this Ordinance for a violation of such nature, and, in case of a violation for which no specific penalty is set forth in the law or elsewhere in this Ordinance, to a fine as specified by the Township's Traffic Penalty and Fines Resolution, Exhibit (A).

Section 104. Experimental Regulations. The Board of Supervisors may, from time to time, designate places upon and along the highways in the Township where, for a period of not more than ninety (90) days, specific traffic and/or parking regulations, prohibitions and restrictions shall be in force and effect, and shall designate such locations by proper signs and markings. Such regulations, prohibitions and restrictions shall be effective just as if they had been specified in this Ordinance. No person shall operate or park a vehicle or motor carrier vehicle in violation of any such regulation, prohibition or restriction, and no person shall move, remove, destroy or deface any sign or marking erected, posted or made by authority of this Section. Any person who shall violate any provision of this Section shall, upon conviction thereof, be liable to the penalty set forth in the law or elsewhere in this Ordinance for a violation of such nature, and in case of a violation for which no specific penalty is set forth in the law or elsewhere in this Ordinance, to a fine as specified by the Township's Traffic Penalty and Fines Resolution. Provided: The purpose of this Section is to allow for the test and experimental determination of the feasibility and desirability of permanent changes in the ordinance of the Township relative to traffic and parking.

Section 105. Authority of Police Officers. The police officers of the Township are hereby given authority to direct traffic on the highways of the Township, and at intersections thereof.

Section 106. Violations of this Chapter. Penalties for any violation(s) of this Ordinance shall be the greater of such penalty as provided by this Ordinance, the Vehicle Code or any other applicable law or regulation.

Section 107. Penalty for Destroying, Etc. It shall be unlawful for any person to willfully destroy, remove or deface any guidepost or sign or index board legally erected upon or near any public street, road, or bridge by the Supervisors, or by any club, association, or other organized body for the direction, guidance, or safety of travelers. It shall also be unlawful for any person to willfully destroy, remove or deface any temporary traffic-control device legally erected for the purpose of enhancing traffic or worker safety in a construction or maintenance work zone, including, but not limited to, cones, batons, barrels, barricades, signs, sign trucks, arrow boards or other devices specified in a traffic safety plan approved by the Township or Department of Transportation. Any person violating this Section shall, upon conviction in a summary proceeding, be sentenced to pay a penalty as set forth in the law or elsewhere in this Ordinance for a violation of such nature.

PART 2. TRAFFIC REGULATIONS.

Section 201. Motor Vehicles Not to Be Driven or Parked on Sidewalks. No person shall operate or park a motor vehicle or a motor carrier vehicle upon any sidewalk in the Township; nor shall any person operate a motor vehicle or motor carrier vehicle upon or across any sidewalk except in order to gain access to or egress from a driveway or alley at such locations where the curb, if such sidewalk is curbed, shall have been properly cut down for that purpose. Any person who shall violate any provision of this Section shall, upon conviction thereof, be sentenced to pay a fine as specified by the Township's Traffic Penalty and Fines Resolution, Exhibit (A).

Section 216. Unlawful to Operate or Park Motor Vehicles on Highways Closed for Construction or Repair. It shall be unlawful for any person to operate or park any vehicle or motor carrier vehicle upon any highway in the Township that is under construction, resurfacing or repair, in disregard of any official sign, barricade or notice that the same is closed to vehicular traffic. Any person who shall violate any provision of this section shall, upon conviction thereof, be sentenced to pay a fine as specified by the Township's Traffic Penalty and Fines Resolution, Exhibit (A).

Section 217. Special Event Highways Authorized. Upon receipt of a written request from a business, association, club or resident for closure of a street, the Board of Supervisors is hereby authorized to designate as Special Event Highways, whenever it shall deem such action advisable and for whatever period of time deemed appropriate, any portion of any highway in the Township whereon any special events, such as Fairs, Shows, Block Parties, Sales, Marathons, Snow Sledding, etc., shall be permitted. Such highway shall be set apart for this purpose under the direction of the Board of Supervisors. No person shall operate any motor vehicle or motor carrier vehicle upon any Special Event Highway at any time when such highway shall be so designated, except in case of emergency, with special permission of the Board of Supervisors or of the police officer in charge, who shall first clear such Special Event Highway of all persons using such highway for the purpose for which it was set aside. Any person who shall violate any provision of this section, shall, upon conviction thereof, be sentenced to pay a fine as specified by the Township's Traffic Penalty and Fines Resolution, Exhibit (A).

Section 218. Accident Reports Required. The operator of any motor vehicle involved in an accident in the Township and required by law to report such accident to any department or agency of the Commonwealth of Pennsylvania, or any other person required to make such report shall, at the time of making such report to the Commonwealth, make a written report to the Chief of Police of the Township containing the same information. Any person failing to make the report to the Chief of Police hereby required shall, upon conviction thereof, be sentenced to pay a fine as specified by the Township's Traffic Penalty and Fines Resolution, Exhibit (A).

Section 219. Penalty for Violation. Any person who shall violate any provision of Part 2, Sections 201 to 217 hereof, shall, upon conviction thereof, be sentenced to pay a fine as specified by the Township's Traffic Penalty and Fines Resolution, Exhibit (A) and costs of prosecution, in default of payment of such fine and costs, to imprisonment for a number of days equal to one (1) day for each ten dollars (\$10.00) of the unpaid balance of the fine and costs.

PART 3. PARKING VIOLATIONS.

Section 301. Parking Without Lights Authorized. The boundary limits of North Cornwall Township are hereby established as a zone in which motor vehicles may remain standing without lights as long as legally parked, and all highways within such boundary limits are hereby designated as highways where motor vehicles may remain standing without lights as long as legally parked.

Section 302. Vehicles to be Parked Within Marked Spaces. Wherever a space shall be marked off on any highway for the parking of an individual vehicle, every vehicle there parked shall be parked within the lines bounding such space.

Section 305. Parking Prohibited Within Thirty Feet of Intersections or Fifteen Feet of Alleys. Parking is hereby prohibited within thirty feet (30') of all intersections and fifteen feet (15') of all alleys located in the Township at any and all times and official signs shall be erected (or are hereby confirmed if heretofore erected) and / or the curbing shall be painted yellow (or is hereby confirmed if heretofore painted).

Section 306. Parking Prohibited in Specific Locations Certain Months, Days, Hours, for Street Sweeping and Winter Snowstorms. Section 308. Handicapped Persons and/or Disabled Veterans Parking Zones. In parking zones for handicapped persons and/or disabled veterans established by Exhibit (B) Handicap Parking Street Address Location Resolution, it shall be unlawful for any person to park any vehicle or motor carrier vehicle, or to allow the same to remain parked, in any such zone, except persons parking vehicles lawfully bearing registration plates or parking placards issued to such handicapped persons and/or such disabled veteran and official signs shall be erected (or are hereby confirmed if heretofore erected). This includes any locations that were issued after the adoption date of this Ordinance and revised by the Township's Handicap Parking Street Address Location Resolution.

Section 309. Parking or Storage of Commercial-Size Private or Business Trucks, Tractors, Equipment, Boats, Recreational Vehicles, Trailers, or any other Commercial Vehicles. It shall be unlawful for any person to park or allow to remain parked, on any street within the Township any commercial-size trucks, cargo vans, tractors, equipment, boats, recreational vehicles, trailers, or any other commercial vehicles.

Exemptions:

- a) Recreational vehicles shall be permitted to load and unload for a period of time not to exceed 24 consecutive hours.
- b) Pickup trucks, vans, or similar size and type trucks used as a business vehicle with less than ten thousand (10,000) pound gross weight classification.
- c) Contractors performing work on a property fronting on such street may be permitted to park commercial vehicles, trailers and equipment necessary for such work for a period of time not to exceed the completion of the work performed. Owners of such vehicles or equipment shall notify the Township Police Department of the identification of the vehicles, type of trailers or equipment parked, location(s) of parking, start date of work, and duration of work.

Section 310. General Parking Regulations.

A. Except when necessary to avoid conflict with other traffic or to protect the safety of any person or property or in compliance with law or the direction of a police officer or other traffic control device, no person shall stop, stand or park a vehicle:

1. In a lane of traffic.
2. On a sidewalk.
3. Within an intersection.
4. On a crosswalk.
5. Alongside or opposite any street excavation or obstruction when stopping, standing or parking would obstruct traffic.
6. Upon any bridge or elevated structure upon a highway or within a tunnel.
7. On any railroad tracks or within 50 feet of the nearest railroad crossing.
8. In areas between roadways or divided highways, including crossovers.
9. In front of a public driveway or in front of a private driveway upon a complaint received.
10. Within 15 feet of a fire hydrant.
11. Within 20 feet of a crosswalk.
12. Within 20 feet of the driveway entrance to any fire station or when properly sign posted, on the opposite side of the street opposite the entrance of any fire station within 75 feet of the entrance.
13. Within 30 feet of upon the approach to any flashing signal, stop sign, yield sign or traffic control located at the side of a roadway.
14. Where the vehicle would prevent free movement of a school bus, municipal bus or other means of public transportation.
15. At any yellow painted curb.

16. In any street or alley less than 18 feet wide.

- B. Blocking garage door entrance. No person, other than the owner or occupant of the garage shall park a vehicle at any time in front of, opposite to or in such a position as to block entrance to or exit by a vehicle from the garage, unless parking in front of the owner's garage by the owner/occupant limits access to other garages.
- C. Maintenance and Repairs of Personal Motor Vehicles and Equipment. It shall be unlawful for anyone to perform repairs or maintenance on their own vehicles or equipment, or on another individual's vehicles or equipment, on the Township streets, alleys, sidewalks, within the right-of-way, or within a Township Park.
- D. Parking or storage of non-inspected, non-registered, non-licensed, illegally registered or inoperable vehicles.
 - 1. No person shall park or leave on the streets, highways or public property of the Township any vehicle without valid registration plates and / or current official state inspection sticker.
 - 2. No person shall park or leave on the streets, highways or public property of the Township any vehicle deemed mechanically inoperable, except in case of emergency or disablement of the vehicle, in which case the operator, within 24 hours, must remove the vehicle from the street, highway or public property.
 - 3. No person shall park or store on the streets, highways, Township-owned property or private property, any vehicle without valid registration plates and current official state inspection sticker, and which is inoperable or has been abandoned.
- E. Parking prohibited on private property.
 - 1. No person shall park or leave unattended a vehicle on private property without the consent of the owner or the other person in control or possession of the property except in case of emergency or disablement of the vehicle, in which case the operator, within 24 hours, must show proof of the emergency or disablement and removal of the vehicle from the private property.
 - 2. The provisions of this section shall not apply to private parking lots unless such lots are posted to notify the public of any parking restrictions and the operator of the vehicle violates such posted restrictions. For the purpose of this section, a "private parking lot,"

means a parking lot open to the public or used for parking without charge; or a parking lot used for parking with a charge.

Section 311. Penalty for Violation. Any person who shall violate any provision of Part 3, Section 301 to 310, hereof shall, upon conviction thereof, be sentenced to pay a fine as specified by the Township's Traffic Penalty and Fines Resolution, Exhibit (A).

PART 4. SNOW AND ICE EMERGENCY.

Section 401. Declaration of Snow and Ice Emergency. In order to facilitate the movement of traffic and to combat the hazards of excessive snow and ice on the highways or portions of highways named in Section 404 of this Part, the Chairman of the Board of Supervisors, in his discretion, may declare an emergency due to such hazards.

Section 402. Parking Prohibited on Specific Highways During Emergency; Restrictions on Operation of Motor Vehicles and Motor Carrier Vehicles on Such Streets. After any such emergency shall have been declared, it shall be unlawful during the period of such emergency for any person to park a motor vehicle or motor carrier vehicle or to allow the same to remain parked, on any highway or portion thereof named in Section 404 of this Part, or to operate any motor vehicle or motor carrier vehicle on any such highway or portion thereof unless such vehicle or motor carrier vehicle shall be equipped with adequate equipment to provide sufficient traction to keep such vehicle or motor carrier vehicle in motion so that other traffic on such highways will not be blocked or seriously impeded.

Section 403. Placement of Signs Along Highways Affected. Information on Existence of Emergency. In order to assist the operators of motor vehicles and motor carrier vehicles in determining the highways affected by this Part, such persons as the Board of Supervisors or Designee shall place around the utility poles on the highways or portions thereof designated in Section 404 of this Part signs reading:

SNOW EMERGENCY ROUTE, SNOW TIRES OR CHAINS REQUIRED
NO PARKING DURING EMERGENCY VEHICLES TOWED AWAY

The Board of Supervisors or Designee shall also, through radio, newspaper or other available media, disseminate information as to the existence of such an emergency.

Section 404. Highways Affected. The highways or portions thereof to which the provisions of this Part shall be applicable during all periods of emergency declared as provided in Section 401 are:

Section 405. Penalty for Violation.

- A. At any time during a period of emergency declared as provided in Section 401 of this Part, any person who shall park a motor vehicle or motor carrier vehicle anywhere upon or along any of the highways or portions thereof listed in Section 404, shall be guilty of a violation of this Part, and, upon conviction thereof, shall be sentenced to pay a fine and costs of prosecution, as specified by the Township's Traffic Penalty and Fines Resolution, Exhibit (A).
- B. Any person who shall operate a vehicle or motor carrier vehicle upon any highway or portion thereof listed in Section 401 of this Part, if such vehicle or motor carrier vehicle

shall become stalled upon any of such streets during a period of emergency declared as provided in Section 401 of this Part, if such stalling shall have been by reason of the failure to have such vehicle or motor carrier vehicle equipped with the equipment hereinabove prescribed, shall be guilty of a violation of this Part, and, upon conviction thereof, shall be sentenced to pay a fine and costs of prosecution, as specified by the Township's Traffic Penalty and Fines Resolution, Exhibit (A).

PART 5. REMOVAL AND IMPOUNDING OF ILLEGALLY PARKED VEHICLES.

Section 501. Authority to Remove and Impound Illegally Parked Vehicles. The Chief of Police of the Township is hereby authorized to remove and impound or to order the removal and impounding, of any vehicle parked on any of the streets, highways or public property in the Township in violation of any provision of the law or of any ordinance of the Township. Provided: no such vehicle shall be removed or impounded except in strict adherence to the provisions of this Part.

Section 502. Approved Storage Garages. Approved storage garages and impounds for the storage of such impounded vehicles shall be specified by the Township's Traffic Penalty and Fines Resolution, Exhibit (A)

Section 503. Garages to be Bonded. Every such approved storage garage or impound shall be bonded in the amount of twenty thousand dollars (\$20,000.00) for the indemnifying of the owner of every such impounded vehicle against the loss thereof, or injury or damage thereto, while in the custody of such impound-keeper.

Section 504. Towing and Storage Charges. Any fees for removal and impounding of each motor vehicle or motor carrier vehicle will be charged at the current established fees required by the towing and impounding companies, and shall be paid by the vehicle's owner directly to those establishments.

Section 505. Notification of Removal and Impounding. Within twelve (12) hours from the time of removal of any vehicle under authority granted by this Part, notice of the fact that such vehicle has been impounded shall be sent by the Chief of Police of the Township to the owner of record of such vehicle. Such notice shall designate the place from which such vehicle was removed, the reason for its removal and impounding, and the pound in which it shall have been impounded.

Section 506. Effect of Payment of Towing and Impounding Charges Without Protest. The payment of any towing and impounding charges, authorized by this Part, shall, unless such payment shall have been made "under protest," be final and conclusive, and shall constitute a waiver of any right to recover the money so paid.

Section 507. Effect of Payment of Charges Under Protest. In the event that any towing and impounding charges, so imposed, shall be paid "under protest," the offender shall be entitled to a hearing before a magistrate or court of record having jurisdiction, in which case such defendant shall be proceeded against and shall receive such notice as is provided in the Vehicle Code in other cases of summary offenses, and shall have the same rights as to appeal and waiver of hearing.

Section 508. Records of Vehicles Removed and Impounded. The Chief of Police shall keep a record of all vehicles impounded and shall be able at all reasonable times to furnish the owners or the agents of the owners thereof with information as to the place of storage of such vehicle.

Section 509. Owner or Operator of Vehicle Remains Liable for Fine or Penalty. The payment of towing and storage charges authorized by this Part shall not operate to relieve the owner or operator of any vehicle from liability for any fine or penalty for violation of any law or ordinance on account of which such vehicle was removed and impounded.

Section 510. Restrictions upon Removal of Vehicles. No vehicle shall be removed under the authority of this Part if, at the time of the intended removal thereof, the owner or person for the time being in charge of such vehicle is present and expresses a willingness and intention to remove such vehicle immediately.

PART 6. MISCELLANEOUS PROVISIONS.

Section 601. Conflicting Ordinances. All ordinances or parts of ordinances conflicting with the provisions of this Ordinance are hereby repealed insofar as they are inconsistent with this Ordinance.


Section 602. Provisions of this Ordinance. The provisions of this ordinance shall be severable, and if any of its provisions shall be held to be unconstitutional, illegal or otherwise invalid, such decision shall not affect the validity of any of the remaining provisions of this ordinance. It is hereby declared as a legislative intent that this ordinance would have been adopted had such unconstitutional, illegal or otherwise invalid provision not been included herein.

Section 603. Effective Date. This Ordinance shall become effective five (5) days from the date of enactment.


