#### **Snow Removal Information**

The Crew: Four full-time employees maintain the Township owned roads after a snowstorm.

The Order of Clearing: Main roads, secondary roads, side streets, developments, then alleys.

The Duration of Clearing: it often takes several passes per side on most streets. It may take the crew hours after the snow ends to clear the roads. Please be patient.

#### DO's and Don'ts

DO make sure your mailbox and support posts are structurally sound. If mailboxes are damaged by snow, slush or ice discharge from the plow chute—and not actually hit by the plow—it is the property owner's responsibility to repair.

DO mark uncurbed lawns with reflective markers within one foot of the roadway. It is impossible for the plow operators to tell where the road ends and the grass begins. If unmarked, lawns could possibly be damaged. The Township will not repair lawns that were not marked.

DO shovel snow away from fire hydrants if you have one on your property so firefighters can locate it in an emergency.

DO utilize off-street parking if available. This aids our plow drivers in clearing as much snow as possible.

DON'T follow too closely or pass plow trucks. Be aware of trucks backing up to clear intersections.

DON'T shovel or blow snow into the street...You will be fined. Not only is it a violation of Nuisance Ordinance #315, this practice may cause street freezing and create hazardous road conditions.

#### REMEMBER!

You must clear public walkways within 24 hours of the end of the snowfall.

Parking Tickets are issued for unregistered, expired registrations, expired inspections/emissions. Parking Ticket Fines are \$50.00 each

<u>Street Sweeping</u>: Street Sweeping starts in April and goes through October. The dates are listed on the calendar. Please adhere to the street sweeping dates, or tickets will be issued with a fine of **\$25.00** 

<u>Driving Safety Tips</u>: Lights on when Windshield Wipers are operating. Snow - Drivers must make "reasonable efforts to remove accumulated ice or snow from the motor vehicle or motor carrier vehicle, including the hood, trunk and roof of the motor vehicle or motor carrier vehicle, withing 24 HOURS after the cessation of the falling snow or ice." Not only is this driver safety – IT IS A PENNSYLVANIA TRAFFIC CODE VIOLATION. <u>Please share the road</u> and give ample room to walkers, runners and bicyclists.

<u>Children Safety</u>: Please be aware of your local bus stop area. Watch out for children crossing the road to enter or exit the bus. Slow down and stop when approaching a bus that is dropping off or picking up children. Please be aware of children crossing the roadway that walk to school during school hours.

<u>Personal Safety Tips</u>: Never leave valuables in your car and always lock your car doors – Always! Leave lights on at night to deter any kind of crime. Scams: These scams mostly target older individuals, by email or by phone. The scams have become more sophisticated and the scammers are usually never caught. <u>Never</u>, give your personal information over the phone or by email. Be vigilant; if it seems too good to be true – it probably is a scam. Government entities will NEVER ask a person for payment in the form of gift cards, iTunes cards, etc.

#### YARD WASTE RECYCLING DROP OFF CHANGE TO RENEWAL PROCESS & NEW CARDS FOR 2024!

The Township operates a Yard Waste Recycling Drop Off Site that is open year-round, every day. Over 300 residents utilize this program with key card access to dispose of acceptable yard waste materials (no grass clippings or dried leaves). The deposited material is taken to a local facility where it is recycled into mulch. Interested in a card for year-round yard waste drop off? It is \$35.00 for your first year (includes a \$5.00 deposit for the card). See us in the offices to fill out the application. Please bring your Driver's License. After the application and waiver are filled out, we can process your payment and promptly activate your card. The card is valid for one calendar year.

<u>Please note</u>: The site is monitored by cameras & violators to our policies will have their card revoked.

If you currently participate in the program, you must come to the new NCT Administrative building at 330 South 18<sup>th</sup> Street to renew for 2024 and receive your <u>new</u> keycard upon renewal.

Interested in a card for year-round yard waste drop off? It is \$35.00 for your first year (includes a \$5.00 deposit for the card). See us in the offices to fill out the application. Please bring your Driver's License. After the application and waiver is filled out, we can process your payment and promptly activate your card. The card is valid for one calendar year.

#### **SPRING YARD WASTE**

#### **COLLECTION DATES & INFORMATION**

#### **APRIL 1st- APRIL 4th**

- Comingle your branches & other yard wastes The comingled pile MUST be placed on the street, stacked parallel with the curb and should be about one foot away from the curb. On narrow streets or on streets with heavy traffic, piles should be as close as possible to the edge of the street and parallel with the curb (piles should be no more than one foot into your yard). No bags, containers, or tarps.
- ♦ You will receive a **NOTICE OF VIOLATION** if you place yard waste out for collection after your collection day has past. **Piles cannot be out more than 2 weeks before the scheduled collection.** All material must be out by 7:00AM on the morning of your collection day. Collections are done by the Township Highway crew, not a garbage hauler.
- Pile size: 8 feet long x 5 feet wide x 5 feet high (approximately a pick-up truck load size). Only one pick-up truck load per house will be collected. **DO NOT** place piles near signs, mailboxes, poles, cars, intersections or any objects which may interfere with loading. Do not place piles on tarps. Curbside collections are provided for routine yard clean-up and recycling, NOT for major vegetation removal or clearing of land.
- ♦ ACCEPTABLE ITEMS: Any garden/flower material, hedge trimmings, tree branches (up to 5 inches in diameter and 8 feet in length), cut hedges/bushes with woody stems, and roots smaller than the diameter of a recycling container (free of dirt).
- NO poisonous plants, grass, ornamental grass, edging, thatch, sod, leaves, stumps, logs, nuts/fruit/vegetables from trees or plants, large amounts of dirt on roots, garden stakes, animal excrement, or other foreign materials.
- ♦ Collection is for Township Residents only, not commercial landscapers.
- ◆ To prevent damage to our equipment, materials will not be collected if regulations are not followed.

You can find your collection day on the color coded map at the end of this calendar.

#### **NCT Street Sweeping Schedule**

In addition to the usual April street sweeping, and to comply with the new Stormwater Management requirements, street sweeping is scheduled for May through October.

#### **BURNING REGULATIONS**

Residential burning is strictly prohibited in the Township! Due to the PA DEP's Act 101 rules for mandated recycling programs, only farmers of normal farming operations (with 25+ acres of contiguous land) may burn yard wastes wholly generated from their farm. Farmers must obtain a permit from the Township prior to burning. Recreational campfires and grills are OK, but please check with the Township for regulations! 717-273-9200





# BEFORE YOU BUY and install an above-ground swimming pool Contact the Township about POOL ZON-ING AND INSTALLATION & REGULATIONS

• Are there Township Zoning Regulations on Swimming Pools? ..... YES! Township Zoning Ordinance #295, Section 319 lists zoning

regulations for permanent and temporary swimming pools.

- <u>Do I need a Township Permit to Install a Swimming Pool? ..... YES!</u> Permanent and Temporary swimming pools require a Township Building Permit or Temporary Pool Permit.
- <u>Do retail store purchased Swimming Pools require a Township Permit? ...YES!</u> These type of above-ground pools are classified as Temporary Pools and the Pool Owners must submit an Annual Township Temporary Pool Permit to install a temporary pool.
- Can I keep a Temporary Pool up year-round? ......NO! Temporary swimming pools must be installed no sooner than May 15<sup>th</sup> of each year and removed entirely by September 15<sup>th</sup> of the same year.
- <u>Do I need to have my pool inspected? ..... YES!</u> Required Zoning placement and yard setbacks will be inspected. All permanent pools and temporary pools with electrical filtration pumps must be inspected under current UCC regulations by an appointed Building Inspector.

#### DRAINING POOL WATER AND PROPER DISCHARGE INFORMATION

DO NOT DISCHARGE ANY POOL WATER INTO THE STREETS, STORM DRAINS, ON YOUR DRIVEWAY, OR ONTO ADJOINING PROPERTIES. <u>Pool Water MUST be dechlorinated!</u> Drain dechlorinated pool water onto pervious stone, mulch or grass areas, slowly using care not to cause soil erosion or drainage onto neighboring properties. The best option for safe pool draining is to contact a pool water removal service.

# PROPERTY MAINTENANCE VIOLATIONS:

The Township will issue a Notice of Violation if your property conflicts with our property maintenance or zoning ordinance. **Common issues include:** 

- Abandoned/Unsecured buildings
- Burning/Outdoor fires
- Dumpsters on public streets (unpermitted)
- Excavating streets or Right-of-Ways
- Fences/Sheds (unpermitted)
- Intersection sight distance problems
- Junk vehicles
- Signs on property (temporary/permanent)
- Storage of refuse/junk
- Street obstructions
- Swimming pools (no fence / unpermitted)
- Tree/Vegetation overgrowth
- Weeds/High grass—Cannot exceed 12" in height.
- Yard Waste dumping
- Shrubbery near the road shall not exceed 30" in height prohibiting site distance for motorists
- Blowing or mowing grass into the street

STREET SWEEP SCHEDULE



Stormwater from your home and from the public streets goes into a storm sewer, which goes directly into streams. This water isn't cleaned in any way and does not go to the waste water treatment facility.

To keep the stormwater sewer system clean you can do the following:

- Do not discharge chlorinated pool water down storm drains or into a creek. De-chlorinate first & drain into your grassy area.
- Check your car for leaks, and recycle motor oil.
- Take your car to the car wash instead of washing it in the driveway.
- Sweep up the grass clippings after mowing your lawn. Never blow grass clippings into the street.
- Do not blow or pile leaves into the streets that may eventually clog storm rains.
- Use pesticides and fertilizers sparingly to prevent polluted runoff.
- Seed or vegetate bare spots in your lawn to prevent soil erosion, and compost your yard waste.
- Direct downspouts away from paved surfaces.
- Capture stormwater with a rain barrel to use for gardening purposes, or let it infiltrate back into the groundwater.

#### What is the Stormwater Fee?

Prior to 2018, the Township was able to fund municipal stormwater related expenditures using revenues from the regular tax collections. The PADEP Pollution Reduction Plan (PRP) was introduced in 2018 and contained more strict and costly unfunded mandates that municipalities were ordered to follow. Because of these DEP-PRP mandates, the Lebanon County Stormwater Consortium was formed to administer and fund the new DEP-MS4/PRP requirements in a cost effective manner. These 6 local municipalities are: North Cornwall Twp, South Lebanon Twp, North Lebanon Twp, City of Lebanon, Cleona Borough and Annville. The Consortium needed to establish the fee to cover the costs of future PRP projects. Each municipality determines their own stormwater fee rates but all share the funds to cover the Consortium's administrative and stormwater projects.

#### What is the Township doing with the Stormwater Fees that are collected?

You will see those dollars in action regularly throughout the Township with street-sweeping, yard waste pick-up, leaf pick-up, and storm clean-up as well as in various Consortium projects throughout the local areas. In fact, the Township was able to purchase their street sweeper with the help of stormwater fee funds. A BIG project recently completed was the Quittapahilla Creek Floodplain Restoration Project.

To allow mowed grass clippings to be blown onto and accumulate on the Township's public streets is a property maintenance and stormwater violation.

The first violation will result in a <u>Warning Notice</u> from the Township. Any additional violations of the same type will result in a <u>Notice of Violation</u> which could **include penalty fees**.



#### FIREWORKS - WHAT YOU SHOULD KNOW...

#### Consumer Fireworks **CANNOT** be discharged or ignited:

- \* Within 150 feet of an occupied structure, whether or not a person is actually present
- \* On a public or private property without express permission of the property owner
- \* From or within a motor vehicle or building OR toward a motor vehicle or building
- \* By any person under 18 years of age
- \* While the person is under the influence of alcohol, a controlled substance, or drugs
- \* Between the hours of 9:00 PM and 7:00 AM

Why must I be 150 feet from an occupied structure when igniting consumer type fireworks?

The PA State and Local Law were created to protect the health and safety of the residents and property owners from the potential hazards of fireworks. Structure fires are increased as a result of consumer purchased aerial fireworks that are set off too close to a structure. Persons responsible for igniting fireworks that cause injuries or property damage could be held liable.



STREET SWEEP SCHEDULE

#### **DON'T POUR FOG—PREVENT CLOGS!**

Fats, oils & grease (**F.O.G.**) going down the drain becomes a very costly maintenance item for the Township's sewer system and the City of Lebanon's wastewater treatment plant. The Township has a **F.O.G.** ordinance, which targets restaurants & food processing establishments that use these materials. The average homeowner should also avoid pouring **F.O.G.** materials down the drain after cooking. Slippery fats, oils, and grease will cause major clogs **somewhere** in the sewer line & affect your sewer bill due to increased maintenance fees. It is unlawful to dispose of this type of material into any sewer system. Take preventative measures to protect your drains & pipes, as well as the sewer system.

Baking goods
Butter, lard, shortening
Cooking oil

Food scraps

Sauces




#### Here are some suggestions:

#### FALL YARD WASTE COLLECTION INFORMATION

#### OCTOBER 7th - OCTOBER 10th

#### ONE WEEK ONLY: Yard Waste only, NO Leaves (leaf pick up begins Oct. 21st)

- Find your collection day on the color coded map at the end of this calendar.
- You will receive a NOTICE OF VIOLATION if you place yard waste out for collection after your collection day has past.
- Piles cannot be out more than 2 weeks before the scheduled collection. All material must be out by 7:00AM on the morning of your collection day. Yard waste collections are done by the Township Highway crew, not a garbage hauler.
- Gather your branches & other yard waste on the street one foot away from the curb. On narrow streets or on streets with heavy traffic, piles should be as close as possible to the edge of the street and parallel with the curb (piles should be no more than one foot into your yard).
- ◆ Pile size: 8 feet long x 5 feet wide x 5 feet high (approximately a pick-up truck load size). Only one pick-up truck load per house will be collected. Do not place piles near signs, mailboxes, poles, cars, intersections or any objects which may interfere with loading. Do not place piles on tarps. Curbside collections are provided for routine yard clean-up and recycling, not for major vegetation removal or clearing of land.

To prevent damage to equipment please follow our regulations. Materials will NOT be collected if regulations are not followed.



#### COLLECTION IS FOR RESIDENTS ONLY - NOT COMMERCIAL LANDSCAPERS



<u>ACCEPTABLE ITEMS:</u> Any garden/flower material, hedge trimmings, tree branches (up to 5 inches in diameter and 8 feet in length), cut hedges/bushes with woody stems, ornamental grass and roots smaller than the diameter of your recycling container (free of dirt).

<u>NO</u> poisonous plants, grass, ornamental grass, edging, thatch, sod, leaves, stumps, logs, nuts/fruit/vegetables from trees or plants, large amount of dirt on roots, garden stakes, animal excrement, or other foreign materials. NO BAGS, CONTAINERS or TARPS.

# LEAF COLLECTION - WHAT DO I NEED TO KNOW? OCTOBER 21 st—DECEMBER 5th

Can I add yard waste to my leaf collection?....NO PLEASE HAVE ONLY LEAVES IN YOUR COLLECTION PILE! ...

No grass, mulch, hedge clippings, branches, sticks, stones, dirt, weeds, nuts/fruit from trees, animal excrement or other green vegetation are permitted.

When should I have my leaves out for collection?.... By 7:00 AM on the day of your collection.

What should my leaf pile look like? ... You should rake leaves into long narrow piles, parallel with the curb line. You should not configure the leaves into round or high piles.

Where should I place my leaf pile?...Please place leaf piles on street and one foot away from curb. If you reside at a NON CURBED STREET you should keep leaves on street and no more than one foot on grass.

Can I bag up my leaves for the leaf collection?...NO Bags and/or containers will interfere with the leaf truck's ability to collect your leaves.

Will the Township still pick up my leaves after Leaf Collection ends?...NO You will receive a NOTICE OF VIOLATION if you place leaves out for collection after leaf collection ends for the season.

Anything else I need to know?... YES Don't place leaves on sidewalks, in yards, under overhanging trees, near vehicles, mailboxes, in alleys or street intersections.

\*\*\* Remember......To prevent damage to collection equipment, regulations must be followed. Your materials will not be collected if regulations are not followed. \*\*\*


